Call to Order

<u>Director and Department Head Reports: Lisa Trevino - Member Services:</u> Trustee Cuthbert was curious about Tech Dept ceased orders for the current fiscal year. The Director said it was easier to end the fiscal year in March. The YouTube group QUIn3Y did return to the library and were given notice of the 12 month Ban for from the library.

Lisa T. presented the new Welcome brochure and the new library cards. Lisa also explained the temporary cards and that we would be using the old library card stock for them.

The Director explained that we are in need of maintenance help from 2-8 pm and Saturdays. She is planning on the social resource coordinator to be bilingual and have a degree. The Director also said the changing of the part time positions to 25 hours would help the daily work schedules. Lisa asked the board to think about it and would bring to the table at next board meeting.
