Permission for Debbie to sign change orders up to \$10,000 without board approval:

Sharon Novak moved and Bonnie Cuthbert seconded the motion to approve the Director's authorization to enter agreement to sign change orders up to \$10,000 during construction.

All present voted aye. Motion carried.

Approval of Minutes: Sharon Novak moved and Judy Koch seconded the motion to approve the September 17, 2020 minutes of the Regular Board Meeting.

All present voted aye. Motion carried.

**Approval of Expenditures:** Bonnie Cuthbert moved and Sharon Novak seconded to approve payment of the October 2020 General/Prepaid bills in the amount of \$97,076.95 (with correction) and additional October 2020 bills in the total amount of \$20,416.76.

All present voted aye on a roll call vote. Motion carried.

Debbie informed the Board that the opening for a circulation Supervisor has been posted. <b>Set Tax Levy for the upcoming tax year:</b> Debbie recommended that we raise the tax levy (4.95%).
Judy Koch moved and Bonnie Cuthbert seconded motion to raise the tax levy by 4.95%.
